### *SDG Localization in Tunisia: A Pathway to Resilience and Innovation Amidst Multiple Crises*

## BACKGROUND

The 2030 Agenda for Sustainable Development faces unprecedented challenges due to the convergence of the current multiple crises, including the ongoing impacts of the COVID-19 pandemic, escalating conflicts, economic instability, and the worsening climate emergency. These crises are disproportionately affecting vulnerable communities and hindering the progress towards poverty eradication and sustainable development. In this context, local and regional governments play a critical role in developing and implementing innovative solutions that address these interconnected challenges and build resilience at the community level.

Tunisia, like many countries, is grappling with the impacts of these crises, particularly in its urban areas where the majority of the population resides. The country's vulnerability to climate change, coupled with social, economic, and political factors, exacerbates the challenges faced by cities. Recognizing the importance of local action, Tunisia has demonstrated a strong commitment to strengthening the role of local and regional governments in sustainable development. This commitment is evident in initiatives such as the development of two Voluntary National Reviews (VNRs), in 2019 and 2021, the National Urban Policy (NUP) project, the publication of the Ennour Voluntary Local Review (VLR), and its involvement in the Local2030 Knowledge and Scientific Network (KSN).

The Ennour VLR, Tunisia's first report on local SDG implementation and progress, serves as a testament to the country's dedication to localizing the SDGs. It highlights the importance of multilevel partnerships and data-driven decision-making in addressing local development priorities and building resilience to multiple crises. The Local2030 KSN further reinforces this commitment by fostering collaboration between researchers, academia, and local governments to develop evidence-based solutions for sustainable urban development.

- Identification of potential areas for further research and action on SDG localization in the context of multiple crises.
